PREAMBLE

Vide Government Order referred to Serial No.1 above Government had approved establishment of an agency under the name and style of Karnataka Udyoga Mitra to provide escort services to industrial entrepreneurs, particularly in the Medium & Large Industrial Sector. The Government had also authorised the Director of Industries & Commerce to take all actions necessary for registration of the society after formulation of suitable articles and memorandum of association, by-laws etc., to meet the objectives set forth in the Government Order referred to at 1 above. The Director Industries & Commerce, vide his D.O. letter referred to at Sl. No.2 above, had forwarded draft memorandum of association and rules and regulations of the Karnataka Udyoga Mitra for Government's approval. Vide D.O. letter referred to at Sl. No.3 above certain views of the Government were communicated to the Director of Industries & Commerce.

ORDER NO.CI 69 SPC 92, BANGALORE, DATED 17TH SEPTEMBER 1992

In the circumstances explained in the Preamble portion of the G.O., Government are pleased to approve the Memorandum of Association and Rules & Regulation of the Karnataka Udyoga Mitra as appended to this Government Order. The Director of Industries & Commerce shall take necessary action to have the society registered under the Societies Registration Act to ensure that the Agency starts functioning at the earliest.
